# 1. FY24 NECSS Joint Agreement Budget

Motion to approve and sign the FY24 NECSS Joint Agreement Budget as presented.

N. Awdziejczyk presented the FY24 NECSS Joint Agreement Budget based on the tentative FY24 budget presented in June. This budget reflects funds received after that meeting, based on the FY23 enrollment in CTE. Our region received the largest allocation for all systems without a career center across the state, and due in large part to the commitment to correctly assigning courses in the system. Dr. Small acknowledged the amount of work and man hours put into properly assigning the courses by NECSS and the representatives from the partners. Dr. Lopez inquired about the revised funding formula. N. Awdziejczyk explained the revision is expected to be released in November and the state has not shared the impact. No public comment is scheduled. NECSS regional CTE enrollment has increased in the past five years. The state will use this year for next year's allocation.

# 2. FY24 NECSS Goals and Areas of Focus

Motion to approve the FY24 NECSS Goals as presented.

N. Awdziejczyk presented a new format for this year's Goals and Areas of Focus. The first goal under Equity for All looking at alignment of placement into Transitional Math and English courses. The second goal for Equity for All is to ensure students have equitable access to dual credit courses. Conduct an audit of dual credit enrollment and create a report and plan of action for any gaps found. Dr. Proctor asked how the committee will define gaps? The taskforce will address this as part of their work. Dr. Lopez asked for follow-up at Council. Dr. Byrne also suggested using specific data from the Equity Journey Continuum to help start these conversations. The third goal highlighted is Regional Alignment and onboarding of new members. Dr. Small suggested if ever there are a lot of new members, then consider a centralized component similar to what was done in the past. The fourth goal is to develop a process for program planning and including increased Advisory participation. Creating a crosswalk to find commonality for alignment. The fifth goal is in student transitions, focusing on opportunities to secure access and support for dual credit students. Finally, under student transitions is a regional awareness of mental health crises and strategies. Ongoing work includes the final year of the Education Pathway grant, as well as the next round of funding for the grant beginning FY25, awaiting the METT grant response, second year of the CCPE grant and the final year of the STAMP grant. Continued oversight of the Career Advisors and working with the Success Coaches. Dr. Proctor highlighted the opportunity of scholarships for students in the early childhood education pathway through ECACE.org.

CTE Education Pathway Grant. The new FY24 METT grant has not yet been approved. The past due balance of funds for the STAMP grant are anticipated to be received this fall.
