N. Awdziejczyk introduced the presenters, and thanked them, as well as Dr. Bates who helped with the presentation, and the entire taskforce for their work this year. Nate Rouse (D220) and Tony Bradburn (D214) shared the findings from this year's work of the Equity for All taskforce. The taskforce looked for equity gaps across several areas of CCRI, using disaggregated data from the NECSS Data Dashboard. A robust dialogue was held around the findings. Dr. Byrne asked if there is a regional list of credentials, and also referenced HB2170 and the Postsecondary and Workforce Readiness Act. The districts expressed the need for training counselors in the areas of student placement, and also asked if its possible for counselors to have access to the Harper student portal to better assist students. The districts inquired if Harper would be able to provide student training on accessing the Harper student portal. The board expressed a need to operationalize educational planning. Additionally, Dr. Proctor made a request for a future presentation on accessing the information in the NECSS Data Dashboard.
