N. Awdziejczyk highlighted progress on goals and areas of focus. Equity for All working through the Power of 15 has identified areas for improvement in shared practices for course placement. Harper is working on a dashboard for baseline data. In alignment with the Equity Journey Continuum, working in collaboration with the Data Committee, a new grouping for review was created for post-secondary attainment. Equity will use this to evaluate the groups to

identify any gaps. A new resource to share with new NECSS members is being created, and follow up continues. An initial crosswalk has been created to support Regional Alignment while working with Harper to increase advisory committee participation. Student Transitions focus on collective efforts and sharing resources at an event to bring the region together. College and Career Pathway Endorsements, Jenny Kloss created a non-traditional campaign shared with the high schools and middle schools called, "You Belong", with the help from high school district representatives.

The proposal includes a breakdown of how the funds are allocated for secondary students and a leadership adjustment for the system director allocation. ISBE budget and finance meeting asked for additional funding, which if approved under an "equitable" formula, 51/53 of the EFE regions would see the same or increased funding, with 2/53 seeing up to 5% reduction.

N. Awdziejczyk commented the plans are resubmitted for approval every year, and suggested unless there are changes to the plan, a three year review should be considered.
